## CONDITIONS

1. Sidestreet Arts LLC (Gallery) and the above named Artist enter upon an agreement to show and sell the artist's work during the Very Merry Cash and Carry Show (Show) from Dec 2 2020 - Jan 3 2021.
2. Artist agrees that their work will be shown in rotation and combination with other Represented Artists.
3. Payment for sold work will be paid to the Artist by check on the 5th of the month following the sale.
4. If work is sold on (three-month) lay-a-way, Artist will be paid percentage as monies come in.
5. Gallery will retain 40% of retail price as commission.
6. In case of theft or damage while in Gallery's possession, original art will be reimbursed at 60% of retail value. Reproductions will be reimbursed for manufacturing cost.
7. Artist agrees that images of their work will be used as Gallery deems appropriate for publicity and promotion.
8. Artist agrees that they will not sell similar items elsewhere for a lower price, except through their own studio.
9. Artist agrees not to remove art from Gallery for private or competing sales during the Show.
10. Artist will deliver art with an inventory sheet that contains the Title, Medium, Dimensions, Retail Price, and Quantity of each item. An inventory sheet is available at [www.sidestreetarts.com/files-for-artists](http://www.sidestreetarts.com/files-for-artists) , or Artist may use their own form, provided all required information is included.
11. All work will be delivered by 5pm on Saturday Nov 28 2020.
12. Artist will clearly mark each piece to correspond to the inventory sheet or provide reference photo guide.
13. All work will be delivered ready to hang or display. Gallery will not wire or apply hanging devices.
14. For any work to be sold online, Artist will provide high-quality photographs by Nov 21 2020. Instructions for photo submission are provided separately.
15. Gallery reserves the right to have the last word in the selection of the artwork, the hanging of the art, and the right to reject work deemed unsuitable for display.
16. Artist agrees to promote their artwork on their own publicity and social media platforms. Such promotion will include #SidestreetArtsPDX and/or @SidestreetArtsPDX.
17. Gallery reserves the right to terminate this agreement after the show. At that time, Sidestreet Arts will consult with the artist regarding progressing with Representation.
